If there is a calm, safe harbor in today's historic economic "Perfect Storm", it is a credit union.

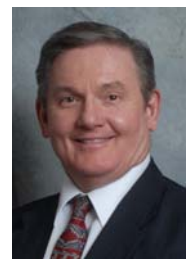
